Pledge of Allegiance.


Invocation.

3. Consider approval of the outstanding bills. Vote on any action taken. (Judge Bray)
4. Authorize the County Judge to enter into a contract with Doucet Engineering for professional services regarding subdivision reviews pending County Attorney approval. Vote on any action taken. (Judge Bray)
5. Consideration and possible action with respect to “RESOLUTION AUTHORIZING PROCEEDING WITH ISSUANCE OF CERTIFICATES OF OBLIGATION AND FURTHER DIRECTING THE PUBLICATION OF NOTICE OF INTENTION TO ISSUE COUNTY OF BLANCO, TEXAS COMBINATION TAX AND REVENUE CERTIFICATES OF OBLIGATION, SERIES 2023”. 8. Adjourn.


