




NOTICE OF MEETING
BLANCO COUNTY COMMISSIONERS COURT

NOTICE IS HEREBY GIVEN pursuant to Chapter 551 of the Texas Government Code (the Texas Open Meetings Act) that a Special meeting of the Blanco County Commissioners Court shall be held on **Tuesday, June 22, 2021** at **9:00 a.m.** in the Commissioners Courtroom of the Blanco County Courthouse located at 101 E. Pecan Dr., Johnson City, Blanco County, Texas, and simulcasted live online at www.YouTube.com , channel “Blanco County”, at which time the following subjects shall be discussed and action considered and/or taken thereon:

1. Call to order and roll call.
2. Pledge of Allegiance.
3. PUBLIC COMMENTS– opportunity for the general public to address the Court on any matter. Comments are limited to 3 minutes.
4. Consider approval of minutes of prior Commissioners Court meeting(s). Vote on any action taken. (Judge Bray)
5. Consider ratifying or approving line-item transfers as presented. Vote on any action taken. (Judge Bray)
6. Consider approval of the outstanding bills. Vote on any action taken. (Judge Bray)
7. Consider proclamation declaring July 2021 as “First Responder Month” in Blanco County. Vote on any action taken. (Judge Bray)
8. Consider authorization for JP #1 office to advertise for employee in both Johnson City and Blanco newspapers. Vote on any action taken. (Judge Bray & Judge Brodbeck)
9. Discussion and possible action regarding opening the exterior doors of the courthouse. Vote on any action taken. (Judge Bray)

10. Consider approval of addendum between Blanco County Precinct 1 Constable Office and Central Square Technologies, LLC. Vote on any action taken. (Judge Bray & Constable Fisher)

Consider authorization for the County Judge to sign a resolution authorizing the County Office of Emergency Management to seek grant funding from the Texas Division of Emergency Management to offset the expense of hiring a consultant to assist with the required 5-year update of the County Hazard Mitigation Plan.
