Record **may also** be downloaded and printed at the TX DPS website https://www.dps.texas.gov with payment by credit card.

Note: Type record required is 3A. Fees for the record must be paid to Texas Department of Public Safety. INQUIRE AT https://www.texasapprovedcourses.com/approved-defensive-driving-list/ FOR STATE APPROVED DRIVER SAFETY COURSES.

PLEASE NOTE: The Judge cannot discuss the merits of a pending judicial proceeding prior to trial [Canon 3(5) Code of Judicial Conduct].

OPTION 1 - Pay Your Ticket*

Determine your fine by the schedule below AND

- 1. complete REPLY FORM by circling plea in Section A at Box 1
- 2. make payment by CASHIER'S CHECK OR MONEY ORDER (No personal checks accepted) payable to BLANCO COUNTY JP COURT
- 3. and MAIL WITH COPY OF CITATION to the COURT listed on your ticket, postmarked by the appearance date noted on your ticket or YOU MAY PAY FINES IN FULL BY CREDIT CARD ONLINE at: http://www.texasonlinerecords.com/blanco

OPTION 2 - Deferred Disposition (Article 45.051 CCP)

If you hold a CDL you are not eligible for deferred disposition. If you qualify for deferred disposition and the Court grants it, you will be assessed fees and placed on unsupervised probation for a period not to exceed 180 days, and if at the end of that period you have complied with the terms of your probation, your case will be dismissed. You must contact the Court for this option. If you are younger than 25 years of age, you must complete a driver safety course as a term of your probation. A fee will be required. Your request must be postmarked by the appearance date on your citation.

OPTION 3 - Take Driving Safety Course

To be APPROVED FOR DSC COURSE-you MUST do ALL of the following:

- 1. Complete the REPLY FORM (other side) FILL OUT EVERYTHING in Section A, and CIRCLE or CHECK Box 3.
- 2. Complete the REQUEST FORM FOR DRIVING SAFETY COURSE AND HAVE NOTARIZED. (other side-Section B)
- Mail NOTARIZED REQUEST FORM, Proof of Insurance, copy of valid Texas driver license and Cashier's Check or Money Order for \$146.00, (in lieu of fine). All items must be postmarked by your appearance date and mailed to the Judge at the address on your ticket. CONTACT COURT TO PAY BY CREDIT CARD for driver's safety course fee only.
- 4. SUBMIT REQUEST FOR CERTIFIED COPY OF DRIVING RECORD (other side Section C) to DPS along with required fee.
- 5. Make sure ALL information is typed or legibly printed. Re-check envelope to make sure all items are enclosed.
- 6 MAIL THIS FORM AND REQUIRED COPY OF DRIVER'S LICENSE, LIABILITY INSURANCE AND PAYMENT OF \$146.00 AND HAVE POST MARKED BY YOUR APPEARANCE DATE. YOU HAVE 90 DAYS TO **COMPLETE** COURSE and submit driving record and course certificate for dismissal.

OPTION 4 - Ask for Trial You will be notified by mail of trial date - you MUST notify court if your address changes You must send:

1. Completed REPLY FORM (other side - Section A, Check Box 4), noting NOT GUILTY plea and desired Judge or Jury trial

OPTION 5 - Do Nothing*

A phone call is NOT an appearance; you MUST enter a plea in person or in writing!

After your appearance date passes and you have failed to appear (enter a plea) in court, you may be charged with an additional violation of Violate Promise to Appear or Failure to Appear and warrants will be issued for your arrest.

The renewal of your Driver's License may be Denied and you will be turned over to an attorney for collection. Additional fees will be applied.

For dismissal of insurance, registration, inspection or driver license violations, contact court for fees and documentation.
