



Purpose:

Self-Contained Breathing Apparatus's (SCBA) are very important in the functions of the jail. Over the past year our current air-packs have needed repairs countless times causing the air-packs to be put out of service. This has caused the jail staff countless hours of worry which have put the jail in non-compliance due to these issues. If and when there is an incident that happens in the jail where the jail staff will need to use the SCBA, it will be a tremendous tragedy if one of the 25-year-old (plus) air-packs malfunction during an emergency and cost a county employee their life or cause them significant injury. The SCBA we currently have are obsolete and the company does not make that brand of SCBA anymore. We need ones that can be maintained at a better cost and that are up-to-date at every entry in case of fire or hazard emergencies. Every County Jailer needs to do a quarterly drill with the air-pack for qualifications per jail standards. The MES Scott 4.5 SCBA has a 10-year warranty. MES is the largest Scott distributor in the U.S. with a 50-million-dollar revenue annually and Scott has been in business for 75 years. These air-packs are a good investment to the jail because some surrounding Fire Departments use them and all the masks and packs will be universal in case its needed. The Annual Service Contract will cancel out our current CimCo service with the current obsolete SCBA.
