Porter and Juneth have been active with the Pleasant Hill-Rocky Creek Community serving as Early Bird 4-H Club leaders, especially the Rifle Club, and the Pleasant Hill-Rocky Creek Community Club. Porter also served as a Director for the Blanco County Farm Bureau in the early 1980's and served as treasurer for the Rocky Creek Cemetery for many years. He and Juneth are active members of the Rocky Creek Church.

Now, therefore I, Judge Brett Bray, Blanco County, Texas, do hereby recognize Mr. Porter Watson for his dedication and service to his country, his family, his church, and his community and wish him a great trip to Washington, DC and many more years of prosperous living.

PIPELINE EASEMENT AGREEMENT

On this 7th date of 1000 , 2019, this Pipeline Easement Agreement (hereinafter "Agreement" is entered into by and between Blanco County, Texas, a political subdivision, whose mailing address is P.O. Box 387, Johnson City, Texas 78636 (hereinafter "Grantor") and Permian Highway Pipeline, LLC, a subsidiary of Kinder Morgan Texas Pipeline, LLC, whose mailing address is 1001 Louisiana Street, Houston, TX 77002 (hereinafter "Grantee").

Easement Property:

Sixty-foot-wide strips of land more particularly described on Exhibit A attached hereto and incorporated herein for all purposes, containing approximately 420 linear feet of land, more or less; and being a part of that certain real property owned by Grantor ("Grantor's Property").

Easement Purpose:

For laying, constructing, operating, inspecting, maintaining, replacing, repairing, protecting, abandoning in place (subject to item 7 of the Terms and Conditions herein), and removing one (1) underground pipeline not to exceed 42 inches in outside diameter and not to be operated under pressure exceeding the maximum allowable operating pressure, including cathodic protection, below-ground valve settings, and any and all other below-ground devices, equipment, appurtenances and structures, and such above-ground devices, equipment, and structures required by law (hereinafter collectively "Pipeline Facilities") that may from time to time be deemed by Grantee to be necessary or desirable in connection with the use and convenient operation of said pipeline for the sole purpose of transporting natural gas under and through the Easement Property. Neither Grantee, nor its assigns, shall place any additional pipelines in the Easement Property.

Consideration:

Ten Dollars and no Cents (\$10.00) and other good and valuable consideration.

Reservations from Conveyance:

- 1. Except as expressly granted herein, Grantee shall have no surface rights. Grantor hereby reserves to Grantor, and Grantor's heirs, legal representatives, administrators, executors, successors and assigns, all mineral interests, whether metallic or nonmetallic, whether similar or dissimilar, whether known or unknown, currently owned by Grantor in, on, and under and that may be produced and saved from the Easement Property or acreage pooled or unitized therewith, and the full and exclusive executive rights to execute leases in connection therewith.
 - 2. Grantor reserves the right to convey to others the right to use all or part of the Easement Property in conjunction with Grantee, as long as such further conveyances are subject to the terms of this agreement. Grantee acknowledges that the minimum depth of Grantee's pipeline was negotiated and established so that Grantor can convey additional underground easements for utility purposes. Notwithstanding the foregoing, Grantor shall not permit any additional pipeline(s) to be installed in the Easement.
- 2. Grantor, as owner of Grantor's Property, and for the benefit of previous and any subsequent Pipeline Easement Agreement

grantees of Grantor, reserves the right to use all or part of the Easement Property in conjunction with Grantee for any purpose that will not interfere with the use of the Easement Property by the Grantee. It being understood, however, that no building or similar permanent obstruction will be placed within or upon the Easement Property, and that there will be no material alteration of the ground surface or grade of the Easement Property without the express written consent of the Grantee, which will not be unreasonably withheld and, to the extent that written permission has not been given, Grantee will have the right to clear and keep cleared from within the Easement Property buildings or similar permanent obstruction, though Grantee has no obligation to do so, and, after said pipeline has been installed, Grantee will not be liable for damages caused on the Easement Property by keeping the Easement Property clear of such unauthorized buildings or similar permanent obstruction in the exercise of its rights hereunder.

Exceptions to Conveyance and Warranty:

This conveyance is made by Grantor and accepted by Grantee subject to any and all existing easements, covenants, rights-of-way, conditions, restrictions, outstanding mineral interests and royalty interests, if any, relating to the Easement Property, to the extent, and only to the extent, that the same may still be in force and effect, and either shown of record in the office of the County Clerk of the County in which any part of the Property is located, or that may be apparent on the Property.

MATERIAL PART OF THE CONSIDERATION, GRANTEE FURTHER EXPRESSLY ACKNOWLEDGES AND AGREES THAT (I) ANY INFORMATION PROVIDED TO GRANTEE PERTAINING TO THE EASEMENT PROPERTY BY GRANTOR HAS NOT BEEN INDEPENDENTLY INVESTIGATED OR VERIFIED BY GRANTOR, (II) GRANTOR IS NOT MAKING, AND HAS NOT MADE, ANY REPRESENTATIONS OR WARRANTIES WHATSOEVER AS TO THE ACCURACY OR COMPLETENESS OF SUCH INFORMATION; AND (III) GRANTOR IS NOT, AND WILL NOT BE, LIABLE OR BOUND IN ANY MANNER WHATSOEVER BY ANY WRITTEN OR **VERBAL** STATEMENT. REPRESENTATION, REPORT, SURVEY. INFORMATION FURNISHED TO GRANTEE, OR MADE BY ANY PARTY WITH RESPECT TO THE EASEMENT PROPERTY OR THE EASEMENT INTERESTS HEREBY CONVEYED. GRANTEE SPECIFICALLY AGREES THAT HAVING BEEN GIVEN THE OPPORTUNITY TO CONDUCT SUCH TESTS, STUDIES, AND INVESTIGATIONS AS GRANTEE DEEMS NECESSARY AND APPROPRIATE. GRANTEE IS RELYING SOLELY UPON GRANTEE'S OWN INVESTIGATION OF THE EASEMENT PROPERTY AND NOT ON ANY INFORMATION PROVIDED BY GRANTOR. GRANTEE FURTHER AGREES THAT GRANTEE HAS PURCHASED AND ACCEPTED THE EASEMENT INTERESTS IN THE EASEMENT PROPERTY IN ITS CURRENT, "AS IS," WITH ALL FAULTS CONDITION, AND TO HAVE ASSUMED THE RISK OF ANY MATTER OR CONDITION WHICH IS LATENT OR **PATENT** REVEALED THAT COULD HAVE BEEN BY INVESTIGATIONS. GRANTOR HAS NOT MADE (AND GRANTOR HEREBY EXPRESSLY DISCLAIMS, AND GRANTOR IS CONVEYING THE PROPERTY WITHOUT) ANY REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, WHATSOEVER, AS TO THE VALUE, CONDITION, NATURE, CHARACTER, SUITABILITY, HABITABILITY, OR FITNESS OF THE EASEMENT

PROPERTY, THE INCOME TO BE DERIVED THEREFROM, THE PRESENCE OR ABSENCE OF ANY HAZARDOUS MATERIAL OR OTHER ENVIRONMENTAL CONDITION OR COMPLIANCE OF THE LAND WITH, OR VIOLATION OF, ANY LAW, STATUTE, ORDINANCE, RULE, OR REGULATION, AND ANY OF SUCH REPRESENTATIONS AND WARRANTIES, AND ANY CLAIMS OR CAUSES OF ACTION AGAINST GRANTOR BASED IN WHOLE OR IN PART ON ANY VIOLATION OF, OR ARISING WITH RESPECT TO, ANY FEDERAL, STATE, OR LOCAL STATUTE, ORDINANCE, RULE, OR REGULATION ARE HEREBY EXPRESSLY WAIVED AND RELEASED BY GRANTEE.

Grant of Easement:

Grantor, for the Consideration and subject to the Reservations from and Exceptions to Conveyance and Warranty, grants, sells, and conveys to Grantee an easement over, under, and across the Easement Property for the Easement Purpose (the "Easement") and for the benefit of Grantee, to have and to hold said Easement unto Grantee, subject to the Terms and Conditions hereof.

Terms and Conditions:

The following terms and conditions apply to the Easement granted by this agreement:

- I. Grantee will have the right to use a temporary construction easement, not to exceed seventy five (75) feet in width (the "Temporary Construction Easement"), for the use and occupancy by Grantee, its agents, employees, contractors, and subcontractors only for the Easement Purpose, and only in connection with and during the original construction of the Pipeline Facilities on the Easement. The Temporary Construction Easement will automatically terminate and revert to the Grantor, free and clear of any right, title, or interest in Grantee, upon whichever first occurs: (i) the completion of construction of the Pipeline Facilities on the Easement; or (ii) twenty four (24) months following the date hereof. The description of the Temporary Construction Easement, and the part of Grantor's Property out of which the same is being acquired, are described in Exhibit B attached hereto and made a part hereof for all purposes.
- Grantee will have the right of ingress and egress to and from the Easement, which right of ingress and egress will be limited and confined to the boundaries of the Easement and to the boundaries of the Temporary Construction Easement while such Temporary Construction Easement remains in effect. Grantee's rights of ingress and egress over the Temporary Construction Easement shall be confined to the above-described Easements during the Temporary Easement Period. After the expiration of the Temporary Easement, Grantee's right of ingress and egress shall be across the Easement, Grantee shall not have the right to cross adjacent land, store materials or equipment on Grantor's adjacent land, or conduct any of Grantee's operations on Grantor's adjacent land, without the prior express written consent of Grantor. Grantee, during any period of construction, maintenance, inspection, repair, removal or replacement of the Pipeline Facilities, taking place after the expiration of the Temporary Easement period, shall be permitted to use a reasonable amount of Grantor's adjoining property, as designated in advance by Grantor, to the extent reasonably available, as determined by Grantor, in its sole and absolute discretion, and only for so long as reasonably necessary for such construction, maintenance, inspection, repair, removal or replacement of the Pipeline Facilities.

After the expiration of the Temporary Easement, except in the case of an emergency, Grantee agrees to notify Grantor not less than seventy-two (72) hours prior to Grantee's employees, agents or contractors entering upon the Easement for construction, maintenance, or repairs. In the case of an emergency necessitating entry upon the Easement by Grantee, its employees, agents or contractors without first giving at least seventy-two (72) hours prior notice to Grantor, Grantee agrees to notify Grantor of the nature and extent of any such emergency within twenty-four (24) hours after any such entry.

Grantee may request an extension to the Temporary Easement period from the Grantor, no less than forty-five days (45) days prior to expiration. Provided that Grantee is making all reasonable efforts to complete the installation of the Pipeline Facilities in compliance with this agreement, Grantor shall extend the Temporary Easement for an additional forty-five (45) days.

- 3. Grantee will begin boring at the easement line unless otherwise agreed by the Commissioners' Court. Grantee will bury the pipeline and appurtenances to provide a minimum ground cover of five feet unless otherwise directed or approved by the County Commissioners. The depth shall be determined from the lowest point of the county right of way to the top of the pipeline or casing.
- 4. Grantee shall install only one pipeline within the Easement. Said pipeline shall be used solely for the purpose of transporting natural gas. Grantee agrees not to transport any material through the pipeline other than natural gas.
- 5. Grantee shall use reasonable efforts not to interfere with, or restrict, the construction, reconstruction, maintenance or repair of a County road, County roadway drainage system, or other County improvement within a County roadway right-of-way, the widening or changing of traffic lanes or other improvement of the roadway or roadway bed, the improvement of drainage facilities, or any other improvement authorized by County to be made in the County roadway right-of-way, upon the giving of thirty (30) days advance written notice thereof by County.
- 6. Grantee shall make reasonable efforts not to block vehicular or pedestrian traffic, to interfere with surface water drainage, or in such manner as to constitute a dander or hazard to persons or property, or to become a nuisance to persons using the County road or living in the vicinity thereof. If public safety requires the temporary closure of a roadway during installation, regardless of duration, Grantee shall provide suitable provision for a temporary by-pass during such installation. Grantee shall be responsible for the costs of any and all barricades, warning signs, lights and flagmen as may be required during installation and/or maintenance of the pipeline crossing.
- 7. In the event of any excavation within the Easements, including but not limited to excavation of any pipeline trench or in the event of removal of the Pipeline Facilities herein contemplated, the top eighteen (18") inches of topsoil (should eighteen inches of top soil

exist), or the full depth of any such top soil, whichever is less, will be removed and stored separately from the subsoil. As the Pipeline trench is backfilled, the subsoil will be replaced over the pipe and pipe bedding and all topsoil will be placed on top of the subsoil, commonly referred to as the double-ditch method. Grantee shall promptly back-fill all excavations in this manner and agrees to promptly remove all excess subsoil from the Easements.

Grantee will promptly (a) restore the ground surface as nearly as practicable to the original contour which existed immediately prior to the commencement of any work; (b) provide suitable ditch cross-overs during construction as are reasonably required by Grantor; (c) properly support each side of a contemplated fence opening by suitable posts and braces before a fence is cut, and, where required, to provide a temporary gate; (d) repair in a good and workmanlike manner any and all fences, parking surfaces, drainage, irrigation, and other utility systems which are cut or damaged by Grantee; and (e) restore or pay Grantor for any damages caused by Grantee or its agents, servants, employees, contractors, or subcontractors to Grantor's growing crops, landscaping, grasses, trees, shrubbery, fences, buildings, drives, parking surfaces, livestock, or other property of Grantor (including the personal property of any tenant, invitee, or permittee) permitted to be located on the Easement by the terms hereof and elsewhere on Grantor's Property as a result of the construction or other pipeline related activities. Grantee shall seed and/or vegetate the Easements, before the expiration of the Temporary Easement, to promote restoration of the pre-project percent vegetative coverage using perennial grass seed or transplant material as per the seasonal recommendations of the County Agriculture Extension Service, or with either common Bermuda grass or other locally adapted perennial grass.

- 8. If the County roadway right-of-way is damaged as a result of, or incident to, the construction, use maintenance or removal of a pipeline, and Grantee fails to initiate restoration of such damaged roadway right-of way within forty-eight (48) hours following notice thereof by Grantor, or fails to diligently prosecute to completion any such restoration, Grantor may cause such restoration to be done, and the Grantee shall be responsible for all costs and expense borne by the Grantor relating thereto. Following any damage or disturbance of the surface or subsurface of a roadway resulting from the installation, use maintenance or removal of a pipeline, Grantee shall be responsible for restoring and reshaping such roadway to its original or better condition.
- 9. Grantee will be solely responsible for the design and construction of the Easement pipeline constructed within the Easement Property, the operation, maintenance, and repair thereof, and any damages resulting from the activities of Grantee hereunder or the use of the Easement Property or any other portion of Grantor's Property by Grantee, or Grantees employees, agents, contractors, customers, or invitees. Nothing contained herein will ever be construed to place upon Grantor any manner of liability for injury to or death of persons or for damage to or loss of property arising from or in any manner connected with the acts, conduct, or negligence of Grantee, or its contractors, in the design, construction, or maintenance of the Easement Pipeline Facilities.
- 10. Insurance/Bond. Without limiting the indemnity obligations or liabilities of Grantee, or its insurers, provided herein, Grantee agrees at all times this Agreement is in effect to carry

and maintain at its sole expense, through self-insurance or policies of insurance ("the Policies") of the types and in the minimum amounts as follows:

- (a) For all its employees engaged in performing work, workers' compensation required by the Texas Workers' Compensation Code, and Employer's Liability insurance with limits of at least \$1,000,000.00 each employee accident and disease, or such similar insurance which is in accordance with state and federal law applicable to said employees.
- (b) Commercial General Liability (CGL) coverage with policy limits of at least \$5,000,000.00 per occurrence and \$5,000,000 general aggregate for operations and activities, including sudden and accidental pollution including cleanup and defense costs for premises and operations including pollution of any body of water, on the Easements and on any Post Construction Work Space.
- (c) Business Auto Liability coverage for all owned, hired, and non-owned vehicles, with a policy limit of \$1,000,000 (Combined Single Limit.).
- (d) Umbrella liability coverage limits of not less than \$5,000,000.00 over and above the underlying primary coverage limits stated in subsections (a), (b) and (c) of this Section. The minimum insurance protection amounts set forth in the Policies shall be increased from time to time upon request by Grantor to an amount which is commercially reasonable at the time.
- (e) A \$1,000,000 Road Maintenance Bond, which shall remain in place for two years, to cover any damage to a county roadway as a direct or indirect result of Grantees use, construction or maintenance of the Pipeline Facilities.

Grantor shall be furnished, to the attention of Grantor's Real Estate Manager, prior to the commencement of any work by Grantee on the Easements or on any Post Construction Work Space, as proof of the insurance required of Grantee a certificate or certificates of insurance (and the endorsements required in this Section shall be attached to the certificate or certificates of the insurance) describing the Policies, which certificates must be acceptable, in their form and content, to Grantor. Each of the Policies will be endorsed to

(i) (except for Workers' Compensation and Employee's Liability insurance) name Grantor, its Port Commissioners, officers, officials, employees and agents as an additional insured to the extent of the liabilities and obligations assumed by Grantee under this easement (ii) provide that it will not be suspended, voided, canceled or reduced in coverage or limits without thirty (30) days' prior written notice to Grantor, Attention: Real Estate Manager, and (iii) provide that notwithstanding any language in any policy of insurance held by Grantor ("Grantor Insurance") to the effect that the Grantor Insurance is primary, the policy or policies held by Grantee are primary coverage and the Grantor Insurance is non-contributory so that Grantor Insurance will not share with the Policies. In addition the Policies shall be endorsed to provide as follows

Grantee agrees that all insurance policies required herein shall include full Waivers of Subrogation in favor of Grantor. Grantee agrees to immediately give to each insurance company which has issued to it policies of insurance applicable to provisions of this Agreement written notice of the terms of the waiver set forth in this Section to the extent such written notice is required by the provisions of the insurance policies, and to have said insurance policies properly endorsed, if necessary, to prevent the invalidation of said insurance coverage by reason of said waiver; and Grantee will provide to Grantor a copy of said endorsement or endorsements or

evidence that such endorsement is not necessary to prevent the invalidation of the insurance coverage by reason of such waiver.

- 11. A written notice shall be delivered to the Commissioners' Court not less than thirty (30) days prior to the removal of any pipeline within the County roadway right-of-way. Such notice shall include a narrative description of the procedures to be employed in such removal, and the specific date and time such removal shall commence.
- 12. Grantee shall place and maintain, at or immediately adjacent to the point where pipelines enter and exit the roadway right-of-way, signs which clearly identify Grantee, a telephone number where a representative of Grantee may be reached twenty-four (24) hours a day, the content of the pipeline, and such other additional information as may be required from time to time by state or federal law or regulation.
- 13. Grantee will immediately, notify the appropriate State and Federal agencies who regulate pipelines of the type in the Easement, and no later than twenty-four (24) hours after discovery, notify Grantor, of any visible or apparent contamination discovered in, on, under, or adjacent to the Easement. If, during, or after, completion of construction of the Pipeline Facilities, the contamination is coming from the Pipeline Facilities, then Grantee will immediately take all steps necessary to shut down the Pipeline Facilities in the Easement from which the contamination is coming, repair or replace the Pipeline Facilities, and restore the Easement to the condition it was in prior to the discovery of the contamination. If the contamination is not coming from a pipeline or pipelines in the Easement, then Grantee and Grantor shall cooperate to determine the source of the contamination and advise the appropriate State and Federal agencies of the occurrence.
- 14. The duration of the Easement is perpetual, subject to the termination provisions herein.
- 15. Notwithstanding the perpetual character of this Easement, if the Easement Pipeline Facilities are abandoned by Grantee, ceases to be used for a period of 24 months excluding periods of force majeure, or any part thereof is removed from the Easement Property by Grantee, then in any such event, the easement, rights, and privileges granted hereby will automatically cease, said easement and rights will terminate, and the Easement Property will be released of and from, and title to the Easement Property will revert to and re-vest in Grantor or Grantor's successors or assigns, free and clear of the easement, rights, and privileges granted hereby as fully and completely as if this easement had not been executed, (and Grantee shall furnish at its expense, upon receipt of written request from Grantor, a release of the Easement) in which event Grantee will have the right to abandon the pipeline in place or remove said pipeline. In the event that Grantee elects to abandon the pipeline in place, Grantee agrees to perform such procedures that are standard to the industry in order to prevent corrosion of the pipeline and/or the escape of any hazardous material from the pipeline. Grantee represents that such standard procedures include, without limitation, cleaning the pipeline, verification that no hydrocarbons remain in the pipeline, and ensuring that the pipeline remains moisture free in order to reduce the possibility of corrosion.

- 16. If the parties determines that an abstract is necessary to complete the conveyances contemplated herein, Grantee shall pay all costs and expenses.
- 17. Grantee covenants and agrees that, in conducting its operations on Grantor's Property, Grantee shall comply with all applicable laws, statutes, rules, and regulations and shall not use the Easement in a manner that may be dangerous or constitute a public or private nuisance. Grantee shall not locate or dispose on or about the Easement any substance that is subject to any law or regulation pertaining to public health, safety, protection, or conservation of the environment. In the event, however, that any contamination should occur on Grantor's Property as the result of Grantee's operations, Grantee shall clean-up such contamination and remediate Grantor's Property to as nearly its original condition as possible.
- 18. This agreement and the exhibit(s) attached hereto, the Master Road Use Agreement and the Blanco County Investments Agreement (Collectively, the Master Pipeline Agreement), are the entire agreement of the parties concerning the use of the Easement Property and the grant of the Easement by Grantor to Grantee. There are no representations, agreements, warranties, or promises, and neither party is relying on any statement or representations of any agent of the other party, that are not expressly set forth in the agreements and any exhibits.
- 19. Except as otherwise provided herein, or except as may be hereafter determined by the parties, no party to this Agreement may sell, assign, partially assign or transfer its interest in this Agreement, or any of its rights, duties or obligations hereunder, without the prior written consent of the other party, except however, Grantee may assign its interest in the Easement to an affiliate or any entity purchasing all or substantially all of Grantee's interests without consent; provided that any such entity agrees to be bond the terms and conditions of the Master Pipeline Agreement. Whenever consent or the approval of a party is require herein, such party shall not unreasonably withhold, delay, or deny such consent or approval.
- 20. This agreement will be construed under the laws of the state of Texas, without regard to choice-of-law rules of any jurisdiction. Venue is in Blanco County, Texas.
- 21. Any notice required or permitted under this agreement must be in writing. Any notice required by this agreement will be deemed to be delivered (whether actually received or not) when deposited with the United States Postal Service, postage prepaid, certified mail, return receipt requested, and addressed to the intended recipient at the address shown in this agreement. Notice may also be given by regular mail, personal delivery, courier delivery, facsimile transmission, or other commercially reasonable means and will be effective when actually received. Any address for notice may be changed by written notice delivered as provided herein.
- 22. Time is of the essence.

Utility Company Permian Highway Pipeline LLC proposes to place a 42" Gas line within County Right-of-Way of River Bend Drive with contractor MPG Pipeline Contractors as follows: approximately 0.1 mi. south of CR 407.

If the proposed installation is a parallel installation, then the installation shall be located two feet within the edge of right-of-way unless otherwise approved by the County.

It is understood and agreed that any damages sustained to the appurtenances installed under this proposal as a result of road construction and/or maintenance, including but not limited to mowing, ditch cleaning, culvert repair or replacement, roadway excavation and base work shall be the sole burden and expense of the owner.

Applicant agrees to notify the Blanco County prior to commencement of any routine of periodic maintenance which requires pruning of trees within the road right-of-way, so that the County may provide specifications for the extent and methods to govern in trimming, topping, tree balance, type of cuts, painting cuts and clean up.

MASTER ROAD USE AGREEMENT

THIS ROAD USE AGREEMENT (hereinafter "Agreement") is made this 71 day of 2019 (hereinafter "Effective Date"), by and between Blanco County, Texas, a political subdivision, whose mailing address is P.O. Box 387, Johnson City, Texas 78636 (hereinafter "County") and Permian Highway Texas Pipeline, LLC, a subsidiary of Kinder Morgan Texas Pipeline, LLC, whose mailing address is 1001 Louisiana Street, Houston, TX 77002 (hereinafter "Company").

RECITALS

WHEREAS, Company desires to conduct operations described as:

installation of a pipeline and appurtenances (hereinafter "Project") that will run through the County in its entirety from north to south;

WHEREAS, Company's agents, employees, affiliates, contractors, subcontractors, workforce and related service companies may utilize equipment and heavy vehicles on County Roads in connection with the above-described operations; and

WHEREAS, Company's use of County Roads may cause impacts which require mitigation and repair to ensure the public's continued ability to use County Roads.

NOW, THEREFORE, IT IS HEREBY AGREED THAT:

1. **Purpose of Agreement**. The purpose of this Agreement is to define the terms and conditions under which the County and the Company agree with respect to the cost of excess maintenance and repair of excess damage arising from the use of County Roads by the equipment and/or heavy vehicles of the Company and/or by Contracting Companies in excess of normal wear and maintenance of County Roads as carried out by the County. This Agreement is intended to engage both the County and the Company in an effort to avoid damage to County Roads and Appurtenances and to minimize interruptions to the traveling public. The parties acknowledge that this Agreement is entered to address these matters and to protect County Roads and Appurtenances from damage.

2. Definitions.

- a. "Appurtenance" means a sidewalk, ditch, culvert, or any type of wall, fence, guardrail, curb, pavement marking, traffic control device, illumination device, mailbox or barrier adjacent to or in, along or on a road, or any construction, obstruction, erection or any situation, arrangement or disposition of any earth, rock, tree or other material or thing adjacent to or in, along or on a road that is not on the traveled portion of the road.
- b. "Contracting Companies" means any agent, employee, affiliate, contractor, subcontractor, workforce or related service companies engaged by the Company in connection with the Company's installation of a cross county pipeline.
- c. "County Roads" means a roadway under the direction, control and management of the County, including:

i. A developed road on which improvements such as grading or surfacing have been made for the purpose of public access and included any Appurtenances, and includes a bridge forming part of a public road and any structure incidental to a public road; and

3. Repair and Maintenance Obligations.

- a. The Company shall be responsible for all costs and expenses required to repair road damages in excess of Normal Maintenance (defined below) of County Roads caused by the Company or its Contracting Companies related to the Project. It is the preference of the parties to this Agreement that all road repair and maintenance work be carried out by the County and reimbursed by the Company.
- b. In the event it is more practical for the Company to perform the necessary repair and maintenance work, County approval shall be required in advance of any repair and maintenance work to be performed by the Company. Any repair and maintenance work performed by the Company or its Contracting Companies shall comply with County standards. If required by the County to fix applicable damages caused by Company, the Company shall provide, at its sole expense, all equipment, materials and labor required to maintain the road surface in the same condition it was immediately prior to the use of County Roads.
- c. The Company and its Contracting Companies shall use commercially reasonable efforts to abate, control and mitigate dust generated as a result of the use of County Roads which is in excess of normal road traffic.
- d. When Company operations are completed, it is agreed that the Company shall perform or provide for all necessary work on County Roads used by the Company and its Contracting Companies to restore those roads to an equal or better condition as they existed on the Effective Date.
- e. During the time when the Company, or any of its Contracting Companies, is engaged in the use of a County Road for access to conduct the installation or maintenance of the pipeline and appurtenances, the Company shall be responsible for road damage and excess maintenance resulting from such use, including but not limited to Examples of Road Damage (defined below) in this Agreement.
- 4. <u>Term.</u> This Agreement shall commence on the Effective Date and shall continue for a period of two years. Notwithstanding the termination of this Agreement, the provisions respecting liability and indemnification, to the extent of liabilities may have accrued prior to the termination, and provisions respecting settlement of accounts, shall remain in full force in accordance with their terms.
- 5. **Pre-Inspection Meeting**. The Company or its designated representative shall meet with the appropriate County personnel in advance to:
 - a. Confirm specific routes for heavy vehicle traffic associated with the conduct of a particular operations;

- b. Confirm with County personnel as to the type of vehicles and duration of road use for a particular operation; and
- c. Discuss the expected damage to occur and the Company's plan for repair during the operation as well as upon completion of the operation.
- 6. <u>Security</u>. On or before the Pre-Inspection Meeting as detailed in Section 5 of this Agreement, the Company or its designated representative shall deliver to the County a Surety Bond or Letter of Credit in the amount equal to one million dollars (\$1,000,000.00) which shall remain in place for a two year period of time to cover Company's obligations hereunder.

7. Inspections.

- a. Inspections of County Roads identified in this Agreement shall be carried out at the following times in the presence of official designates of both the County and the Company at a time set by the County or the County's official designee if so agreed to by the Company:
 - i. Prior to use of County Roads a video route review shall be performed to establish a baseline of each roads pre-construction condition; and
 - ii. Following completion of the installation of the pipeline and appurtenances or any maintenance thereon a second video route review shall be performed to either identify areas which need additional attention or acceptance by the County of performed restoration.
 - iii. At the request of the County.

8. Description of County Roads.

- a. The following is a fair and correct description of the normal use and condition of County Roads to be used hereunder:
 - i. County Roads are gravel and paved roads.
 - ii. County Roads are generally 24 feet to 32 feet in width.
- b. The Company will be responsible for all costs required to repair road damages in excess of Normal Maintenance of the County Roads caused by the Company or by its Contracting Companies. Normal Maintenance of County Roads as carried out by County includes but is not limited to the following:
 - i. Pothole patching is completed throughout the asphalt production season.
 - ii. Grading is performed on a routine schedule based upon traffic loads and surface conditions.
 - iii. Shoulder maintenance is performed on a routine schedule, based primarily on weather conditions. Typical shoulder maintenance occurs two to three times per year.
 - iv. Ditch cleaning is done as necessary, usually due to storm conditions or gradual sediment build-up.
 - v. Culvert replacement is performed as pipes wear out or are damaged.

- vi. Culvert flushing is only necessary when pipes are plugged, which is typically due to heavy storm run-off.
- vii. Gravel top coating is applied throughout the year as necessary.
- viii. Asphalt-paved surfaces are maintained, as necessary with maintenance activities that include, but are not limited to pothole patching, crack sealing, and pavement failure remove and replace.
- c. Examples of Road Damage include but are not limited to the following:
 - i. Potholes or wheel-depressed areas after the roads have been maintained or graded.
 - ii. Damage to shoulders due to heavy vehicles running off the edge of the road.
 - iii. Damage to ditches due to heavy vehicles squeezing the ditches closed by running on the shoulders of the road.
 - iv. Damage to culverts crushed by heavy hauling activities or being "plugged" by sediment from closed ditches.
 - v. Damage to road surface causing the re-cycling of the surface for the purpose of proper roadway drainage.
 - vi. Damage to the existing base by heavy traffic.

9. County Road Use Deviations and Restrictions.

- a. If it becomes necessary by either party to change a route of travel, the other party shall be notified in writing as soon as possible.
- b. The County reserves the right to determine the hours during which vehicles and equipment may be moved on County Roads covered by this Agreement, and may temporarily suspend approvals under this Agreement if, in the opinion of the County, acting reasonably, the prevailing weather conditions, or emergencies warrant such suspension.
- 10. **Emergencies**. The County may, in emergency situations, and acting reasonably, and without giving any notice to the Company as required elsewhere in this Agreement, take immediate and all action necessary to complete repairs to County Roads that the County deems necessary for public safety.
- 11. <u>Indemnification</u>. The Company shall indemnify, release and hold harmless the County and its officers, agents, employees, successors and assignees from any and all actions, proceedings causes of action, claims, demands and/or costs attributable to, whether directly and indirectly, damages or injuries arising out of or resulting from acts or omissions by the Company or otherwise arising out of the performance under this Agreement by the Company, its employees, agents, contractors or subcontractors, or its Contracting Companies, but such indemnity shall not apply to the intentional acts or negligence of the County, its officers, agents, employees, successors and assignees.

- 12. <u>Force Majeure</u>. No party shall be deemed to be in default with respect to non-performance if due to strikes, lockouts, fire, storm, acts of God or terrorists, or any other cause (whether similar or dissimilar to those enumerated) beyond the party's control; but lack of finances shall in no event be deemed to be a cause beyond a party's control.
- 13. Assignment. Except as otherwise provided herein, or except as may be hereafter determined by the parties, no party to this Agreement may sell, assign, partially assign or transfer its interest in this Agreement, or any of its rights, duties or obligations hereunder, without the prior written consent of the other party. Whenever consent or the approval of a party is require herein, such party shall not unreasonably withhold, delay, or deny such consent or approval.

14. Waivers.

- a. Failure by either party to this Agreement to enforce or insist upon compliance with any of the terms or conditions of this Agreement shall not constitute a general waiver or relinquishment of any such terms or conditions, but the same shall be and remain at all times in full force and effect.
- b. By entering this Agreement, the County does not waive, nor shall it be deemed to waive, any immunity or defense that would otherwise be available to it against claims arising by third parties.
- 15. <u>Successors and Assigns</u>. This Agreement shall inure to the benefit of, and be binding upon the County and the Company and their respective successors and permitted assigns.
- 16. **Severability**. If any provision of this Agreement shall be held invalid, illegal or unenforceable in any respect by a court of competent jurisdiction, such invalidity, illegality or unenforceability shall not affect any other provision of this Agreement.
- 17. **Choice of Law.** This Agreement shall be interpreted in accordance with the laws of the State of Texas, and all obligations of the parties hereto, created by the Agreement are performable in Blanco County, Texas. Venue of any suit or cause of action under this Agreement shall lie exclusively in Blanco County, Texas.
- 18. **Entire Agreement**. This Agreement constitutes the entire agreement and understanding between the parties and supersedes any prior agreement or understanding relating to the subject matter of this Agreement.
- 19. **Modification**. This Agreement may be modified or amended only by a duly authorized written instrument executed by the parties hereto.
- 20. **Notices**. Any notice required or permitted under this agreement must be in writing. Any notice required by this agreement will be deemed to be delivered (whether actually received

or not) when deposited with the United States Postal Service, postage prepaid, certified mail, return receipt requested, and addressed to the intended recipient at the address shown in this agreement. Notice may also be given by regular mail, personal delivery, courier delivery, facsimile transmission, or other commercially reasonable means and will be effective when actually received. Any address for notice may be changed by written notice delivered as provided herein.
