




NOTICE OF MEETING

2. PUBLIC COMMENTS – opportunity for the general public to address the Commission on any matter. Comments are limited to 3 minutes.
3. Consider approval of minutes of prior Election Commission meeting(s). Vote on any action taken. (Judge Bray).
4. Consider applications and possible action regarding appointment of an Elections Administrator. Vote on any action taken. (Judge Bray)
5. EXECUTIVE SESSION: Pursuant to Texas Government Code Sections 551.074, Personnel Matters, to interview Elections Administrator applicants and/or deliberate and 551.071, Consultation with Attorney.
6. RETURN TO OPEN SESSION: to consider acting on any posted item.
7. Adjourn.

For purposes of time management, the Court reserves discretion to limit the number of presentations.
