At its Feb. 20, 2025 meeting, the Lower Colorado Regional Water Planning Group (Region K) approved its Initially Prepared 2026 Region K Water Plan (IPP). Region K also authorized its administrative agent, the Lower Colorado River Authority (LCRA), to submit the IPP on or before March 3, 2025. The IPP was submitted to the Texas Water Development Board on March 3, 2025.
