AMENDED ORDER AND NOTICE OF INCORPORATION ELECTION

ON THIS 14th day of March 2025, came to be considered the application filed with the County Judge of Blanco County, Texas, on May 14, 2024, seeking to incorporate the City of Hobbes, Texas (“the Application”). On January 31, 2025, an Order was signed and entered approving the Application and calling the election for May 3, 2025. This Amended Order is being signed and entered to provide additional necessary information to conduct the election that has been called.

THE JUDGE FINDS (i) the Application is in due form; (ii) was signed by more than 10% of the qualified voters of the area sought to be incorporated, who are qualified voters under §11.002 of the Texas Election Code; (iii) the boundaries of the proposed city are duly set forth, and a proper legal description thereof accompanies the Application; (iv) there are more than 200 and less than 4,999 inhabitants in the proposed City of Hobbes, Texas; and (v) the inhabitants of said territory are entitled by law to incorporate themselves into a city, if a majority of them vote in favor of such incorporation.

IT IS THEREFORE ORDERED that the registered voters of the area sought to be incorporated are entitled to vote (i) for or against the question of the incorporation of the City of Hobbes, Texas, under the provisions of Chapter 8 of the Texas Local Government Code; and (ii) for a Mayor for the City of Hobbes, Texas, for City Commissioner Place 1

for the City of Hobbes, Texas, and for City Commissioner Place 2 for the City of Hobbes, Texas; all being under the provisions of §24.021 of the Local Government Code.

IT IS FURTHER ORDERED the Incorporation Election and Election of Initial Officers shall be held as a Joint Election with other local political subdivisions in accordance with Chapter 271, Election Code, and the following Countywide Vote Center polling places will be used with voting hours from 7:00 am to 7:00 pm on May 3, 2025:
