### OPTION 2 – Deferred Disposition (Article 45.051 CCP)

If you hold a CDL you are not eligible for deferred disposition. If you qualify for deferred disposition and the Court grants it, you will be assessed fees and placed on unsupervised probation for a period not to exceed 180 days, and if at the end of that period you have complied with the terms of your probation, your **case will be dismissed.** You must submit your plea to the Court with copy of driver's license and proof of liability insurance for this option. Judge Riley requires a DSC with all deferrals, so if you are eligible for DSC, you may want to choose that option.

If you are younger than 25 years of age, you must complete a driver safety course as a term of your deferral order. A fee will be required. Your request must be postmarked by the appearance date on your citation.

### OPTION 3 - Take Driving Safety Course THE FORM MUST BE NOTARIZED FOR DRIVER SAFETY COURSE.

To be APPROVED FOR DSC COURSE-you MUST do ALL of the following:

- 1. Completely FILL OUT EVERYTHING in Section A, and B, answer questions True or False, check #3 box (on other side) AND HAVE SIGNATURE NOTARIZED.
- 2. Mail **NOTARIZED FORM**, Proof of Insurance, driving record, copy of valid Texas driver license and Cashier's Check or Money Order for \$146.00. <u>All items must be postmarked by your appearance date and mailed to the Judge at the POST OFFICE BOX address.</u> SEE ADDRESSES BELOW. CHECK BOX in section B ON FORM IF YOU WISH TO PAY THE \$146.00 BY CREDIT CARD.
- 3. REQUEST TYPE 3-A DRIVING RECORD FROM DPS WEBSITE @ www.dps.texas.gov/DriverLicense/driverrecords.htm
- 4. MAIL all documents to correct Court and have postmarked by your appearance date. YOU HAVE 90 DAYS TO COMPLETE COURSE. Calculate deadline from your appearance date. You MUST submit court certificate of completion for dismissal.

#### NOTE: DRIVER SAFETY COURSE IS NOT AVAILABLE IF YOU HAVE A COMMERCIAL DRIVER LICENSE VIOLATIONS OF 25 MPH OR MORE OVER POSTED SPEED LIMIT. OFFENSES IN CONSTRUCTION OR MAINTENANCE WORK ZONE WHEN WORKERS ARE PRESENT OR FOR SOME SCHOOL BUS AND ACCIDENT VIOLATIONS

# **OPTION 4 - Ask for Trial** You will be notified by mail of trial date - you MUST notify court if your address changes You must send:

1. Completed REPLY FORM-see other side – see Section A, Check Box 4, noting NOT GUILTY plea and desired Bench Trial or Jury trial

2. Submit a copy of Driver's License & completely fill out Section A, including phone number.

### **OPTION 5 - Do Nothing** A phone call is NOT an appearance; you MUST enter a written plea in person or by mail!

After your appearance date passes and if you have failed to appear to enter your plea in court, you may be charged with an additional violation of Violate Promise to Appear or Failure to Appear, and warrants will be issued for your arrest.

The renewal of your Driver's License may be Denied and you will be turned over to an attorney for collection. Additional fees will be applied.
