




NOTICE OF MEETING

Pecan Dr, Johnson City, Blanco County, Texas,** at which time the following subjects shall be discussed and action considered and/or taken thereon:

1. Call to order and roll call.
2. Pledge of Allegiance.
3. Consider approval of minutes of prior Commissioners Court meeting(s). Vote on any action taken. (Judge Bray).
4. PUBLIC COMMENTS– opportunity for the general public to address the Court on any matter. Comments are limited to 2 minutes.
5. Consider ratifying or approving line item transfers as presented. Vote on any action taken. (Judge Bray)
6. Consider approval of the outstanding bills. Vote on any action taken. (Judge Bray)
7. Consider proclamation declaring April 2019 as “Child Abuse Prevention Month” in Blanco County. Requested on behalf of the Blanco County Child Protection and Family Advocacy Board. Vote on any action taken. (Judge Bray)
8. Consider proclamation declaring April 14-20, 2019 as “National Public Safety Telecommunicators Week”. Vote on any action taken. (Judge Bray)
9. Consider authorization for the County Judge to sign the 2019 Property Insurance Renewal questionnaire with Texas Association of Counties (TAC). Vote on any action taken. (Treasurer Swift)

10. Consider burn ban. Vote on any action taken. (Judge Bray)

Disruptive or repetitious presentations are not allowed. For purposes of time management, the Court reserves discretion to limit the number of presentations.
