Pecan Dr. Johnson City, Blanco County, Texas**, at which time the following subjects shall be discussed and action considered and/or taken thereon:

- 1. Call to order and roll call.
- 2. Pledge of Allegiance.
- 3. Consider approval of minutes of prior Commissioners Court meeting(s). Vote on any action taken. (Judge Bray).
- 4. Consider ratifying or approving line item transfers as presented. Vote on any action taken. (Judge Bray)
- 5. Consider approval of the outstanding bills. Vote on any action taken. (Judge Bray)
- 6. Consider renewal of FY 2017-18 Interlocal Agreement with The County of Burnet for Jail Inmate Services. Vote on any action taken. (Judge Bray)
